SICK LEAVE FOR DEPENDENT CARE

The new Memorandum of Sick Leave for Dependent Care agreed upon during the term of the 1995 National Agreement provides that sick leave may be used by an employee to give care or otherwise attend a family member with a medical condition which, if an employee had the same condition, would justify the use of sick leave. The sick leave that an employee is allowed to use under the MOU is not additional sick leave: it is simply the earned sick leave that the employee has accrued under the USPS's regular sick leave policy as set forth in the ELM, Sec. 513. The limit an employee can use for dependent care purposes is no more than 80 hours of his/her earned sick leave within each leave year.

Dependents under the MOU are defined as family members which would include son, daughter, parent and spouse.

Approval of sick leave to care for a family member is the same as it is for approval of sick leave for the employee. Therefore, the employee should normally submit a PS Form 3971 for approval in advance to the appropriate supervisor. To obtain approval of sick leave under the MOU, the employee must provide the following information in the remarks section of Form 3971 or on an attachment thereto. First that sick leave is requested to care for or attend to a dependent. Second, the employee must specify the medical facts and provide the necessary explanation and/or documentation in support of the illness, incapacity, or other condition affecting the dependent in order for the supervisor to determine whether the same condition--if afflicting the employee--would warrant use of sick leave. Third, the employee must state the nature of his/her need to care for or attend to the dependent.

Subs have a probationary period and then other rights and protections under the national rural carrier agreement. Regular carriers and sub carriers can join a QWL/EI work team as a member.

ATTENTION: MILWAUKEE DISTRICT RURAL LETTER CARRIERS

If your route has just been adjusted, and due to that adjustment, it places you in 2 different evaluations, you need to let your postmaster, or supervisor know, if you desire to be in the higher route classification. This decision will be dependant upon the fact that you are in the leave category 6 or 8.

According to Sean Gorzalski, Customer Service Analyst in Milwaukee, if you are presently at a High option, and the adjustment places you in either of 2 catagories (46J/42K), the computers in Minneapolis will not automatically place you in the higher classification. You just simply have to inform your manager of your desire.

SECTION A - AUTHORIZATION BY EMPLOYEE

This assignment, authorization and direction shall be irrevocable for a period of one (1) year from the date of delivery hereof to you, and I agree and direct that this assignment, authorization and direction shall be automatically renewed, and shall be irrevocable for successive periods of one (1) year, unless written notice is given by me to you and the Union not more than twenty (20) days and not less than ten (10) days prior to the expiration of each period of one year.

This assignment is freely made pursuant to the provisions of the Postal Reorganization Act and is not contingent upon the existence of any agreement between you and my Union.

Contributions or gifts (including dues) to the NRLCA are not tax deductible as charitable contributions. However, they may be tax deductible under other provisions of the Internal Revenue Code.

In 1991 the USPS and the NRLCA through the QWL-EI process created the Rural Carrier Training Academy. This letter is for rural carriers, RCA'S and RCR'S who have been through the training academy or if your relief person has been through the academy. The State Board would appreciate any feedback we can get about the training academy. We would like to know how you think the academy training is going. To those of you that have been through the academy, please give us information on what items or subjects you could have used more training on before you went to your route. Please let us know what you think was not useful or of very little importance on being a rural carrier. We would also appreciate this kind of information from the rural carriers who have a RCA or RCR who been through the class. If you have ideas on how to make the training better, please let us know. Your postmasters comments would also be appreciated if they want to give us their feedback. Would you please put on your feedback sheets at what training academy (city) the training took place. Any and all feedback would be greatly appreciated. Thank you for your help. Help us make the training academies the best we can. Send your feedback sheets to:

I would like to let you know what the DJSC is doing with the training academies. Within the next couple of months the training in Green Bay will go from 5 days to 6 days. The first two days of training will remain the same. The third day of training will be changed. On the third day the new carriers will go back to their office and ride on their assigned route and watch the regular carrier perform the duties of the route. The trainees that live far away and do not travel back and forth to Green Bay will ride with a regular carrier out of Green Bay. The trainees will then finish out the week with classes on rural carrier duties and responsibilities. This program will be tested in Green Bay and then be evaluated. We hope the trainees will have a little more knowledge of what a rural carrier does before they come to class. We hope this additional day will help. If we lose some after the third day, so be it. I would rather have them quit here than to carry my route or your route one day and then quit. The DJSC is also looking into new evaluation sheete. One would go to the new trainee, one to the regular carrier and one to the postmaster. We hope this would help us to better evaluate the training academy. For those of you that might be interested, there is going to be one and possibly two trainer instructor job openings in Green Bay.

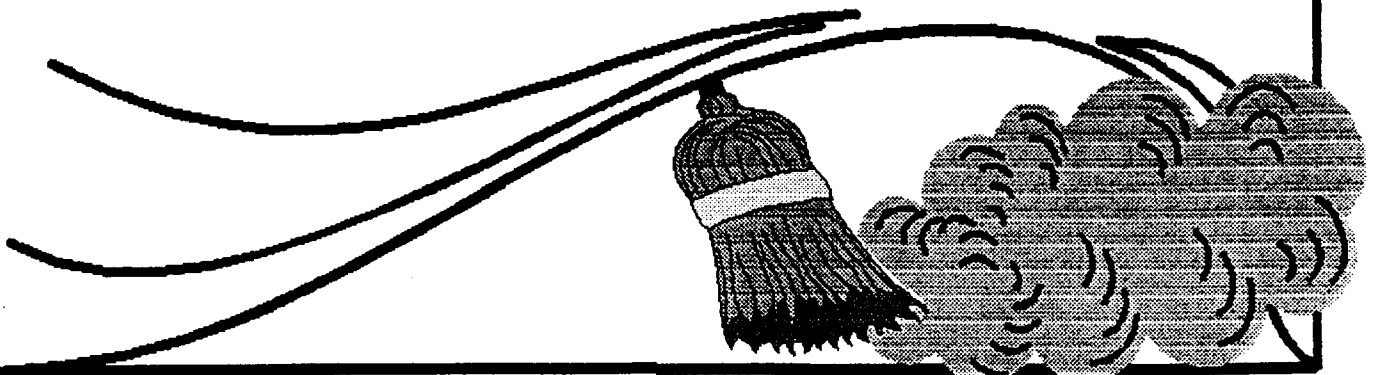

HOW CAN I MAKE SURE MY VOTE COUNTS?

Every year, as an Association member, you receive a ballot to vote for your choices for National Convention Delegates -- people YOU CHOOSE to represent YOU and YOUR VIEWS at the National Convention. This year's Convention will be held in Charleston, West Virginia on August 6 - 9, 1996. Last year, Wisconsin seated 29 Delegates whose mileage and per diem were paid by the WRLCA Association members. Last year, this expense amounted to \$20,700.00!! And it is YOUR OPPORTUNITY TO CHOOSE THE MEMBERS YOU FEEL WILL BEST REPRESENT YOU!! **CHOOSE WISELY! CHOOSE PEOPLE YOU KNOW WHO WILL ATTEND IN YOUR BEHALF AND LET THEM KNOW HOW YOU FEEL ABOUT UPCOMING ASSOCIATION ELECTIONS AND FUNCTIONS.** Reading through some of last National Convention minutes about "floor action" might also give you some of ideas of how Delegates spoke in your behalf in New Orleans last August. Lastly, if you are not sure how to cast your vote -- ask a trusted Association member or State Board Member who has experience and knows which Delegates' judgment would match your concerns. But most important: VOTE!!

There are some new wrinkles in the procedures of ballot voting this year, and these must be observed closely. Do not let your ballot become "void" due to some error on your part. Do not put "write-in candidates" on the ballot; do not write anything on the ballot! Do not sign the ballot or make comments.

Due to nationwide balloting procedures varying, National has set forth the new procedures outlined below which all states are asked to observe beginning with this year's National Convention Ballot:

1. Mark an "x" or "✓" on the line next to the name of the candidates of your choice. Mark no more than 29 names (less is fine, but no more). Ballot cannot contain any identifying information (your initials, name, comments, etc.)

2. Place your marked ballot in the small envelope labeled "BALLOT" and seal it. Do not write on this envelope. You must use this small envelope. This envelope protects your ballot secrecy.

3. Insert the sealed "BALLOT" envelope containing your marked ballot into the return envelope pre-addressed to PO Box 902, Manitowoc, Wisconsin. Stamp, indicate your proper return address, and mail promptly. ALL BALLOTS MUST BE MAILED TO THIS ADDRESS. NO "hand-carried" BALLOTS WILL BE ACCEPTED.

4. Your name on the return ballot envelope will identify you as an eligible member/voter. If in question, a member's status can be determined to establish eligibility to vote.

5. On Saturday, June 8, 1996, the Chairman of the Elections Committee or their designee will pick up ALL returned ballots. The PO box will be closed at that time, and any arriving after that date, will be returned because the box has been closed.

6. The Elections Committee will then proceed to count and post results of the National Delegate Election to the State Convention attendees. The Election Committee members must be made up of people who are not listed on the ballot. Candidates listed on the Ballot may observe counting procedures as long as their presence is not disruptive or distracting. This activity, too, would be overseen by the Chairman of the Elections Committee. The State Secretary will continue to supervise and answer questions the Elections Committee may have in regard to their duties.
