Wisconsin Rural Letter Carriers' Association Welcomes NRLCA Executive Committee Chair, Nicky Phillips and NRLCA Auxiliary Executive Committee Secretary, Marlene Cummings to the 119th WIRLCA State Convention



Nicky Phillips was re-elected to the National Board of the National Rural Letter Carriers' Association at the 117th National Convention in Grand Rapids, Michigan on August 18, 2023, to serve a one-year term as Executive Committeeman.

Nicky was hired as a Rural Carrier Relief (RCR) in 1985 and converted to Rural Carrier Associate (RCA) in 1988. He served as a leave replacement for 11 years until becoming a regular carrier in February 1997. He was a facilitator with the QWL/EI process and a member of the DJSC for 6 years.

Starting in 1997, Nicky began his role as a local steward, then moved up to Assistant State Steward in 2009. He was elected as District Officer of District 6 and served for 12 years. Later, he served as a State Officer for 3 years and held an appointed officer position on the Georgia State Board. Prior to his election to the National Board, he spent 10 years as an Assistant District Representative with the National Steward System.

Marlene Cummings was elected to the National Auxiliary Board in Orlando, FL, in 2022. She currently serves as Executive Committee Secretary.



She is no stranger to the rural carrier craft. She has been involved since she was 14 years old, as her dad and mom were

vital members of the Iowa Association and Auxiliary. Her husband, Gary, has carried mail for over 30 years while serving the past several years as full-time DR and/ or ADR for the IA-NE-SD District.

Marlene and Gary have two adult children, Sara, who is very involved in Special Olympics, and Clint and his family. Marlene enjoys attending her granddaughters' activities whenever possible.

Marlene has served as president, vice president, and secretary of the Iowa Auxiliary. She currently serves as co-editor of the Iowa newspaper. Marlene is looking forward to working with the Association, Auxiliary, and Junior Auxiliary members to continue growing the NRLCA Auxiliary.

WIRLCA Board Positions

Each and every member of the National Rural Letter Carriers' Association has the same opportunity to become a leader within our organization. Whether it is in the role of a state and/or local board member, or a member of the steward system, I would like to take a moment to speak about the positions within our state association's board.

Members running for any WIRLCA board position have the responsibility to represent the interests of the entire membership, uphold the values and objectives of the union, and promote transparency and accountability in the decision-making processes. They should actively engage with fellow members to understand their concerns and priorities, develop clear platforms outlining their goals and plans, and participate constructively in discussions and debates.

Additionally, candidates should adhere to our union's bylaws and election procedures, maintain integrity throughout the campaign, and respect the democratic principles of the organization.

At our state convention in June of this year, we will again be seeking candidates for our state board. Your current WIRLA state board feels it is important for there to be education regarding the duties and expectations of these roles. I have created a "snapshot" of the expectations of these roles with the hope it will aid you in determining whether or not you would like to seek candidacy for office. It is important to note that all existing and newly elected board members will be expected to attend a post-convention board meeting the Monday directly after the convention.

In all instances, members are prohibited from participation in the Association while serving in managerial or supervisory positions, such as Officer-in-Charge (OIC), Acting Supervisor (204-B) or Postmaster Relief (PMR) or acting in any

capacity normally performed by a manager. Members who accept managerial positions shall be deemed to have



resigned from all elected and appointed positions within the Association and shall be prohibited from holding any elected or appointed union positions for a period of one year from the last day served in that capacity.

In each of these roles, there is the expectation of each member to: Attend and present at local meetings and fall regional seminars, and attend all board meetings (Frequency is currently every two to three months, give or take.), as well as attend the Spring Conference, Mid-States, State Convention, and National Convention. Each member will be assigned to local units/regions within our district and is expected to be the main point of contact for support.

All board positions will be compensated as specified in Section 4 of the WIRLCA constitution.

Below are duties as outlined in the *WIRLCA Constitution, The NRLCA State Officer Resource Manual,* and the *WIRLCA Board Policies.* With all positions, additional duties may apply.

The President, Vice-President, Secretary/ Treasurer, and Assistant Secretary/Treasurer shall serve one (1) year terms or until their successors are elected and installed. The Executive Committee shall serve three (3) year terms or until their successors are elected and installed.

Executive Committeeman: The current board is made up of three committeemen. This is a three-year staggered term, with one position rolling off each year. Depending on seniority/ appointment, duties may include: making arrangements for meetings, care of flags/

State and National Delegates

State Convention Delegates play an important role in our association. I want to thank each person who became a delegate this year for accepting this very important role for your local unit. It is important to have each local represented by at least 1 delegated member.

How is the number of delegates determined? The local unit receives 1 delegate for every five (5) of its members, or a major part thereof, based on the membership as of February 1st of the current year.

What happens now that you're a delegate? First, you'll need to register for the state convention. This ensures you have an official printed name badge, materials ready, and confirms our delegate strength. It also helps us recognize 1st timers who will need more guidance as well as the individuals willing to serve on committees. I also ask that you please consider purchasing meal tickets, at minimum for the Banquet as it is sure to be a wonderful time.

What if you didn't become a delegate at your local unit? You can still attend! You just do not get voting rights.

What do delegates vote on? They vote on the state board elections, the resolution changes, and constitution changes. If the state had any appeals, they would also play a voting role in the appeals.

Who can be a delegate? Any dues-paying ARC, RCA, PTF, Regular carrier, or retiree in good standing.

What happens if my local does not have anyone present at the state convention? Your local units' votes are subtracted from the total votes eligible. Remember 1 vote for every 5 members, so that means some locals receive 7 votes while others receive more than 30 votes.

What if my local only has

one delegate attend? If only one member attends, that one delegate receives all votes eligible for their local. This can get hand-cramping for this individual having to write the state officer election names many, many times if they have more than 15 votes for the unit they represent.

If you did not get elected a delegate this year, I hope you will consider it for next year's state convention in Brookfield. Remember, you can be a voice if you attend as a delegate.

NRLCA's Nicky Phillips will be present in Fond Du Lac with all the latest National information. Please look over the tentative schedule on page 18.

National Delegate nominations are due May 2nd in the designated PO BOX. Those nomination forms can be found in the National Magazine from December 2023 to April 2024. The assigned PO box is listed on the back of the nomination form. Nominations are only accepted in that PO BOX, and it is closed on May 2nd, 2024. NO EXCEPTIONS. This is a Department of Labor regulation to be closed 50 days prior to the state convention.

The election committee will be meeting on May 15th, 2024, in Tomah at Perkins at 9 am to start verifying all nominations, do the ballot draw order, and create the ballot. The ballot is printed outside of our organization by The O'Brion Agency in Portage, WI. The election committee picks up the ballots when they return for their next meeting.

Constitutional Change and Resolution Submissions

One of the many benefits of being a member of the Rural Letter Carriers Association is the ability to submit resolutions/constitutional changes to promote change to parts of the contract or state/national constitutions to improve the working conditions of the rural craft. Over the past month, the Wisconsin State Board has been attending local county unit meetings encouraging carriers to submit resolutions to solve some of the issues or problems they've been experiencing over the past year. Attending your local county meetings is the first step to solving issues that arise, changing the contractual language is а permanent solution to solving those problems.

The first part of writing a resolution would be to locate the *Constitution/Resolution change* forms. These can be found in your magazine or on the WIRLCA.ORG website. To access the website, you must log in using the password, click on the home button choose the ABOUT US tab then the WIRLCA Constitution tab. This will bring up links to the constitution along with forms for both the constitution and resolution change forms. One important thing to note at the top of the page is there will be a cutoff date for submitting your resolutions by mail or email, if you miss those dates you will have to submit your resolutions under new business at the state convention.

How to choose which form to use, the constitution change form would be used to change the language currently in our constitution, or any additional language you would like to add to the constitution. The resolution form can be used to change both things currently in our contract or things governed by the National and State Associations.

Filling out the form is easier than it looks. First, choose your issue then find where the language is located that covers your issue. Is it a BINDING (an idea or solution the union would have

control of enforcing) or a NON-BINDING (an idea or solution that would have to be agreed

upon by both our union and the postal service) resolution? WHEREAS is the current language as it reads now, BE IT RESOLVED would be the new language you're proposing for the change.

When writing out the whereas section try to avoid using "wiggle words" (can, may) that give the Postal Service the option of doing something. Instead, try using words like will or must.

The INTENT is the reason behind the change, the explanation of what the new language is trying to accomplish with the change. The intent needs to be written so it's easily understood what you're trying to accomplish with the new language.

Once you've accomplished writing out the resolution you can now mail it to the address on the top of the page or send it by email. Your submitted resolutions will be typed up and presented to the Constitution/Resolutions Committees two days prior to the state convention. The appropriate committees will verify each form for accuracy. Should they have any questions about your resolution they will call you with the daytime number you provided. It's important you include the daytime number you can be reached at on June 20, 2024.

What happens at the state convention?

Unfortunately, many members do not know the answer to this question. Some members believe that it is just an excuse to go off and have a good time like a vacation. Some members just aren't that interested. Some members will go to the convention every year as delegates. Those who go to the state convention every year already know what happens there. For first-time goers or those who have never gone before hopefully, this article will give you some insight as to what goes on at the state convention every year.

The National Rural Letter Carriers Association is made up of state and territory associations. The state and territory associations are made up of county or district associations. It all starts at your local district or county meeting.

The state convention attendees are elected delegates from the county or district associations. These local associations elect delegates at their annual meeting to represent them at the state convention. These delegates have the responsibility of representing the local units and their interests at the state convention.

So, what do your delegates do at the convention? They represent you. Your local unit gets one delegate for every five union members you have. Some counties send their full delegates strength while other local units send less and there are a few that don't send any delegates at all.

The delegates vote for your state officers. With the election of officers, the local units get the vote their full County strength. For example, if your local unit only sent two delegates but they're eligible for 15, then they will get to vote all 15 votes for whatever officer position they are voting on. If the local units sent zero delegates, then that local unit doesn't get any votes cast for the officer position that's being voted on.

Your delegates also decide on resolutions and constitutional changes.

Resolutions are submitted by members to direct the national board to negotiate whatever they want done during the next contract negotiations or to make a change in how the union is operated. Examples of a contract resolution would be something like wanting to eliminate table 2 tier pay or wanting postal vehicles for all routes. An example of a resolution to change the NRLCA constitution would be wanting to lower your dues or pay national officers more money. With these votes, it's just one vote per person not the full delegate strength of the local unit.

So how does the order of the business go for the state convention? It can be overwhelming but it's fairly straightforward and simple.

The first day of the convention consists of seminars in the morning and a joint session in the afternoon. The seminars usually cover retirement and steward-chosen topics. A joint session is when the rural carrier delegates, members of the auxiliary association, and members of the auxiliary junior association all meet together. The joint session mainly covers a welcome from the host motel, the presentation of gavels, and introductions. This is also the time guest speakers from USPS and the Union speak. The joint session finishes on Saturday morning.

Saturday afternoon and Sunday are the closed sessions where the business of the union is conducted. The credentials committee reports on delegate strength and the numbers needed for majority votes for officer elections. Then there is a roll call for delegates when voting cards are distributed. The financial report is given. After that, delegates hear reports from the

Summer is coming

With that in mind, I believe it would be a perfect time to emphasize their visit with letters from those of us who didn't make that trip to D.C. The legislative issues that are currently listed on the NRLCA website are as follows below, pick the issue that you feel impacts you the most. I would say without a doubt that the most important issue to the majority of Rural Carriers is the so-called "Buy Back Bill" and it happens to be the one bill that has been reintroduced into the last two sessions of Congress. This is a good sign because the more it comes up the more support it gains, and I believe with continued support it will be passed into law at some point in the future. The bottom line is "It's Up to Us" to keep the issues on the minds of our Representatives.

The easiest way to find your representative's contact information is to simply go to www.house.gov and input your zip code and to get our Senators contact information go to www.senate.gov and choose our state.

These are the current issues that are listed on the NRLCA website when you click on the legislative tab. Keep in mind if you go to www.nrlca.org and click on the legislative tab each of these issues has a link to a form letter available for your convenience.

POSTAL ISSUES:

<u>H.R. 7629</u>: "Protect Our Letter Carriers Act" H.R. 7629 appropriates \$1.4 billion to modernize the arrow key with a new electronic version, as well as review the sentencing guidelines of crimes against postal employees and appoint an assistant U.S attorney with the responsibility of prosecuting crimes against postal employees. Visit the website to read the press release with a quote from NRLCA President Don Maston.

<u>H.R. 3721</u>: "USPS Shipping Equity Act" H.R. 3721 would provide the United States Postal Service the authority to mail alcoholic beverages. To see the press release from Congressman Newhouse and Congresswoman Wexton with a quote from the NRLCA visit the NRLCA website.

RETIREMENT:

H.R. 5995: "Federal Retirement Fairness Act (FRFA)" On October 19, 2023, Representatives Derek Kilmer (D-WA), Gerry Connolly (D-VA), Don Bacon (R-NE), and David Valadao (R-CA) introduced the Federal Retirement Fairness Act (FRFA), more commonly referred to by rural letter carriers as "buy back" legislation. The Federal Retirement Fairness Act would "amend title 5, United States Code, to provide that civilian service in a temporary position after December 31, 1988, may be creditable service under the Federal Employees Retirement System." This would provide rural letter carriers who served as relief employees after December 31, 1988, the opportunity to buy back credit for service. The FRFA impacts not only rural letter carriers but other federal employees as well, who began their employment as non-career workers and did not ability have the to make retirement contributions. <u>H.R. 82</u>: "Social Security Fairness Act of 2023" H.R. 82 eliminates both the WEP and GPO. H.R. 82 would repeal provisions that reduce Social Security benefits for rural letter carriers who receive other benefits such as a state or local government pension. H.R. 82 restores retirement benefits for rural letter carriers, and other public servants, who are impacted by the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). Both provisions unfairly penalize and reduce retirees' incomes by thousands of dollars every year. When a retiree is living on a fixed income, this reduction in retirement benefits can have a significant impact on the retiree.

The WEP applies to retirees who receive both a pension from non-covered work and Social Security benefits. WEP can reduce a retiree's benefit by as much as \$512 per month. Currently, there are about 2 million retirees impacted by WEP. The GPO reduces most, and sometimes all, a spouse's or widow's benefits for retirees who also receive a pension for non-Social Security work. Bob Lueck-PAC

The resolutions and constitution committee take the longest. The constitution committee reads off proposed changes to the state constitution. Then the resolutions committee introduces the finding resolutions which are used to propose changes to the NRLCA Constitution. After that, the resolution committee reads off the nonbinding resolutions which are items the membership submitted to be considered for making changes to our contract with USPS and future negotiations.

Once this is done you have the election of your new state officers and any new business that might be introduced. The convention finishes up at this point.

It may seem tedious but this is what takes place at your state convention. This is one piece of the puzzle of how your union works and where business is conducted for the running of the association.

banners, or appointment as a designated insurance representative.

Committeemen are expected to assist other officers as needed and perform other duties as assigned by the president.

Assistant Secretary/Treasurer:

The assistant secretary/treasurer is tasked with sending recruitment letters, mailing various correspondence, taking board and convention minutes, processing <form>1187's for new members and <form>1187-R's for recently retired members as well as completing longevity awards. The assistant secretary/treasurer will discharge other duties as assigned by the secretary/treasurer and/or the president. The assistant secretary/treasurer will assume the duties of the secretary/treasurer in cases of death, resignation, disability, or disqualification until an election is held and a successor is elected and installed.

Secretary/Treasurer: The expectations of this role are quite vast and a considerable amount of commitment should be expected. It is helpful to have some extent of accounting knowledge, but it is not a requirement.

The secretary/treasurer will work conjunctly with the president and his/her duties. This position requires: Keeping accurate records of this association's proceedings, conducting and records the keeping of association's correspondence, issuing and keeping records of payments for invoices and payroll, receiving and depositing all funds, keeping the charge of all books, records, and papers of the association and communicate with and provide contact information to new members and newly eligible regular carriers.

The secretary/treasurer is expected to maintain the database, keep an accurate record of inventory/equipment, and update board policies. The secretary/treasurer will keep true and correct accounts between the association and the various county units, distribute per-capita dues, provide necessary materials to county units prior to their annual meetings, and in conjunction with the assistant secretary/ treasurer, shall train local officers at the WIRLCA Spring Conference.

Duties will also include oversight of the election process and will assist the Financial Review Committee with all state financial reviews.

Vice President: This position will help and instruct fellow board members and assist the president where needed. He/she will maintain and update *The Guidelines for State Convention*. The vice president shall act in the absence of the president and shall become president in cases of death, resignation, disqualifications, and removal of the president until such a time as a successor is duly elected and installed. The vice president shall appoint a committee to select the member of the year.

President: The president shall preside over all meetings, enforce all laws, give general direction of all association affairs, and sign all required documents. The president shall appoint members to committee assignments and with the approval of the board, appoint a webmaster and editor. The president shall review each publication of the *WIRLCA News*. The president shall have the authority, with the approval of the executive board, to appoint association officers, such as legal council or other services.

I encourage you to run for positions within this great union of ours. Running for leadership roles is a great way to show dedication and commitment to serving our membership. It also encourages a culture of participation and engagement within the membership and can create positive differences.

With God giving us the patience needed, and with the experience, we can have a new outlook and hope in the New Year.





Another spring conference gone and another successful event. It was nice to talk to carriers I haven't seen in a while and catch up on the happenings in their offices. During the spring conference, there was some confusion about how regular carriers' overtime pay works when they volunteer to work on Sundays or help on other routes. The overtime is calculated based on the Table and step you are on, at a 40K rate. For example, if you are a 45K on Table One on Step 5 you are making \$82,702 per year or \$39.76 per hour. Your per-hour wage has your 5 hours of overtime built in. When working on another route in compliance with the MOU, the post office does not use \$39.76 to figure out what you're owed because you would be getting paid overtime on your overtime rate. A 40K on table one, on step 5, is \$69,641 or \$33.48 per hour. If you work 5 hours on another route or Sunday, USPS will take the \$33.48 x 5 hours x 1.5 to come up with \$251.10 (minus normal customary deductions) which is correct. I see a lot of carriers taking the 39.76 x 5 x1.5 which is \$298.20 and not correct. Any additional questions or explanations please contact a district-level steward.

Now, if you are a PTF rural carrier and recently worked over 40 actual hours in a pay week, you will notice that on your paycheck, the overtime rate is not paid at 150% of your straight-time rate. The overtime hourly rate for PTFs is figured out by dividing the annual salary of their attained step of a 40-hour evaluated route by 2080 hours. The reason that 2080 is used, is because overtime is not calculated for the portion of the straight-time rate attributed to holiday pay compensation. RCAs also have a unique pay system based on the number of hours they have worked. Sometimes they are paid for the evaluation of a route and sometimes they are paid hourly, it depends on the situation. If an RCA works over 40 hours in a week, you will be paid 40 hours of straight time, and the remaining time would be paid at time and a half. The 45 hours worked would be 40 hours of straight time and 5 hours paid at time and a half, regardless of what routes you were on. Once you do go over 40 hours, you are no longer paid for the evaluation of the route.

Let's use an example:

RCA Bob worked 39 hours in a week and makes \$20.38 per hour.

-Monday, he worked 9 hours on a 9.4-hour route

-Tuesday, worked 7 hours on an 8-hour route

-Wednesday, he worked 7 hours on a 9-hour route

-Thursday, he worked 8 hours on an 8.6-hour route

-Friday, he worked 8 hours on a 9-hour route

-Saturday and Sunday, Bob went to a wedding and didn't work

How many hours is Bob getting paid for?

Since Bob stayed under 40 hours for the week, Bob is paid the route's total evaluated hours (44) x 20.38 = \$896.72 instead of (\$794.82) which is the total hours he worked 39 x \$20.38 his hourly rate of pay. That's a good deal!

Using the same hours Bob worked Monday – Friday above, let's say management required him to come in on Saturday to run parcels for two hours before he left for his wedding. What happens to his pay? Because he went from 39 total hours to 41 total hours, Bob is now paid 40 hours of straight-time pay and 1 hour of overtime.

Since Bob crossed 40 hours, the evaluation of the routes does not matter. This can be extremely costly to the RCA. Instead of getting paid the \$896.72 for working 39 hours, Bob is now getting paid \$845.77 for working 2 hours more!

This is because 40 hours x \$20.38 = \$815.20, and then you add to that 1 hour multiplied by the OT rate of \$30.57 to get your total of \$845.77.

This method of calculating can be both advantageous or detrimental depending on how you choose to view it, your work ethic, or sheer luck (good or bad).

The important thing is that you are informed and understand how these calculations work.

Light Duty versus Limited Duty & Accident Reporting

When a carrier is injured **on the job**, Articles 13.1 & 13.2 of the National Agreement address any work injury a carrier may sustain along with a possible limited duty assignment.

EL-902 (National Agreement aka "The Contract") ARTICLE 13 ASSIGNMENT OF ILL OR INJURED EMPLOYEES

Section 1. Assistance for Employees

The Employer will make an effort to assist employees who through occupational injury or occupational illness are unable to perform their regularly assigned duties. This effort will consist of possible assignment to limited duty work if such is available.

Section 2. Federal Employees' Compensation Act

It is understood that the provisions of this Agreement are subject to the obligations and responsibilities imposed by the Federal Employees' Compensation Act and its implementing regulations. Recognizing the mutual obligation to be fully responsive to the requirements of the Federal Employees' Compensation Act, the parties will cooperate in making every effort to ensure that employees with job-related illnesses or injuries are returned to duty subject to their medical restrictions.

CA-1 and CA-2 are described below. You must request a CA-1 Notice of Traumatic Injury or CA-2 Notice of Occupational Illness or Disease from your employing agency when injured on the job, if not incapacitated. The carrier also has the option to fill out the CA-1 or CA-2 through ECOMP at <u>https://www.ecomp.dol.gov</u>

Illness/Injury that occurs cumulatively over time and no one specific incident can be identified Complete a form CA2, Notice of Occupational Disease and Claim for Compensation

Traumatic Injury occurs at a specific time (Report immediately) CA1, Federal Employee's Notice of Traumatic Injury and Claims for Continuation of Pay/Compensation

provides management a doctor's note with restrictions, they do not return to work until they have been cleared 100% to work or have reached out to DRAC (District Reasonable Accommodation Committee) and received approval. Also, restrictions are sometimes put on non-injured carriers.... For example, pregnancies, mental health (anxiety), and religious beliefs. Article 13.3 still applies, but DRAC can be utilized to help you. If you have any questions about DRAC please talk to a district-level steward or information is also on liteblue.

EL-902 Article 13.3

Section 3. No Light-Duty Assignments

In the rural carrier craft, at any local installation, regular rural routes shall not be considered for any light-duty assignment.

It is the responsibility of the carrier to report all accidents whether big or small to management. Accident reporting instructions are in the PO-603 *Rural Carrier Duties and Responsibilities* Section 173 below.

173 Accident Reporting

173.1 Vehicle Accidents

173.11 Notify Postmaster or Supervisor

Report all accidents. Having your own automobile insurance does not relieve you of the responsibility to submit a report on Standard Form (SF) 91, Operator's Report of Motor Vehicle Accident, to your postmaster or supervisor.

173.12 Carry Report Kit

A <u>Vehicle Accident Report Kit, Item 087-H</u>, must be carried in the vehicle when it is used for official business (see <u>Exhibit 173.12</u>). Request this kit from the postmaster or supervisor and be sure the envelope is sealed. If it is not, obtain a sealed replacement.

173.13 Remain at Scene

If involved in an accident, regardless of the cause or the amount of damage, injury, or death, remain at the scene until you have:

a. Obtained aid and assistance for any injured person.

b. Safeguarded the scene against further accident.

c. Secured and protected the mail.

d. Notified the postmaster or supervisor, or designee.

e. Notified local or state police as required.

f. Provided other drivers or principal parties to the accident the information required by law using <u>PS Form 4585</u>, Postal Driver Accident Information (see Exhibit 173.13f).

g. Obtained, as far as practicable, the names and addresses of all principals and witnesses using <u>PS Form 4586, Accident Information</u> (see Exhibit 173.13g). Do not make any statements admitting personal

or postal liability, or criminal negligence, or attempt to negotiate an agreement or settlement with anyone.

h. Completed SF 91. This report (see Exhibit 173.13h) may be prepared at the scene of the accident or immediately after. You must submit it to your postmaster or supervisor before going off duty on the day of the accident. Regardless of the amount of damage, injury, or deaths, accidents must be reported on SF 91 even though the other principals involved state that no claim will be filed for or against the Postal Service or its employees. SF 91 is also required for accidents involving other postal personnel, equipment, vehicles, or property. Note: If you are physically unable to comply with the preceding instruction, the postal official in charge ensures that the required investigations and reports are made.

173.2 Accidents (Other Than Vehicle) If you are injured on the job:

a. Notify your postmaster or supervisor so <u>PS</u> <u>Form 1769, Accident Report</u>, can be completed (see Exhibit 173.2a). For details, see ELM 820. b. Obtain a Form CA-1, Federal Employee's Notice of Traumatic Injury and Claim for Continuation of Pay/Compensation, from your postmaster or supervisor any time you are injured on the job. Complete and return it to your postmaster or supervisor within 48 hours of the time of injury (see Exhibit 173.2b). For details see ELM 540.

What A Federal Employee Should Do When Injured At Work



Report to Every job-related injury should be reported as soon as possible to your supervisor. Injury also means any illness or disease that is caused or aggravated by the Supervisor employment as well as damage to medical braces, artificial limbs and other prosthetic devices. Before you obtain medical treatment, ask your supervisor to authorize medical Obtain treatment by use of form CA-16. You may initially select the physician to provide Medical Care necessary treatment. This may be a private physician or, if available, a local Federal medical officer/hospital. Emergency medical treatment may be obtained without prior authorization. Take the form CA-16 and form OWCP-1500/HCFA-1500 to the provider you select. The form OWCP-1500/HCFA 1500 is the billing form physicians must use to submit bills to OWCP. Hospitals and pharmacies may use their own billing forms. On occupational disease claims form CA-16 may not be issued without prior approval from OWCP. File In traumatic injuries, complete the employee's portion of Form CA-1. Obtain the form from your employing agency, complete and turn it in to your supervisor as Written Notice soon as possible, but not later than 30 days following the injury. For occupational disease, use form CA-2 instead of form CA-1. For more detailed information carefully read the "Benefits ..." and "Instructions ..." sheets which are attached to the Forms CA-1 and CA-2. A "Receipt" of Notice of Injury is attached to each Form CA-1 and Form CA-2. Your Obtain supervisor should complete the receipt and return it to you for your personal **Receipt of Notice** records. If it is not returned to you, ask your supervisor for it. Submit Claim For If disabled due to traumatic injury, you may claim continuation of pay (COP) not to exceed 45 calendar days or use leave. A claim for COP must be submitted no later COP/Leave and/or than 30 days following the injury (the form CA-1 is designed to serve as a claim for continuation of pay). If disabled and claiming COP, submit to your employing Compensation agency within 10 work days medical evidence that you sustained a disabling For Wage Loss traumatic injury. If disabled beyond the COP period, or if you are not entitled to COP, you may claim compensation on form CA-7 or use leave. If disabled due to occupational disease, you may claim compensation on form CA-7 or use leave. A claim for compensation for disability should be submitted as soon as possible after it is apparent that you are disabled and will enter a leave-without-pay status.

The Federal Employees' Compensation Act (FECA) is administered by the U.S. Department of Labor, Office of Workers' Compensation Programs (OWCP). Benefits include continuation of pay for traumatic injuries, compensation for wage loss, medical care and other assistance for job-related injury or death. For additional information about the FECA, read pamphlet CA-11, "When Injured at Work" or Federal Personnel Manual, Chapter 810, Injury Compensation, available from your employing agency. The agency will also give you the address of the OWCP Office which services your area.


