Report of the Constitution Committee to the 119th WIRLCA Convention in Fond Du Lac, WI June 25, 2024

CHANGED LANGUAGE: Effective January 1, 2024

Section 4. Compensation.

A. Allowances

- 1. Increases in allowances shall be adjusted on an annual basis, July 1 of each year. The increases shall be equal to the total percent of pay raises paid regular rural carriers by contractual agreement in the preceding year, to include COLA.
 - a. The 2024 allowance of the State President shall be \$320.00 \$330.00 per month.
 - b. The 2024 allowance of the State Vice-President shall be \$187.00 \$193.00 per month.
 - c. The 2024 allowance of the State Secretary/Treasurer shall be \$741.00 \$767.00 per month. (Unless in a temporary full-time status.)
 - d. The 2024 allowance of the Assistant Secretary/Treasurer shall be \$404.00 \$417.00 per month.
 - e. The 2024 allowance of the State Committeeperson shall be \$143.00 \$148.00 per month.

These allowance figures shall be updated at each subsequent printing of the Constitution.

- 3. The State Association shall pay the Newsletter Editor \$629 \$649.00 plus approved expenses for the production of each issue of the State Newsletter and is to be increased proportionately to any changes in the Rural Carrier Evaluated Schedule, 46K, Step 12.

- C. Delegate slips signed by the County President and County Secretary shall be submitted to the State Secretary/Treasurer in order to allow elected Delegates to vote. Delegates must present themselves to the Credentials committee.
 - 1. The only way Members may be authorized by the delegation to have voting rights is if they arrive at the convention after the Credentials committee has been dismissed and their county had submitted their name as a delegate.

INTENT OF / REASON FOR CHANGE:

This language was included so that a carrier who had been elected as a delegate at their county meeting but was unable to arrive before the Credentials committee was dismissed may become a voting delegate. This would allow a carrier who worked Friday and Saturday to still attend and vote on election of officers and other matters brought before the body.

- A. Each county association shall be entitled to one delegate elected by secret ballot to the State Convention for every five (5) of its members, or major part thereof, based on the membership as of February 1st of the current year.
 - 1. If the number of candidates to be delegates to the State Convention are equal to or less than the number authorized, a motion to suspend the rule calling for a secret ballot election may be introduced and that all candidates be declared duly elected delegates to the Wisconsin State Convention.

INTENT OF / REASON FOR CHANGE:

That a secret ballot election would not be necessary when there are less candidates for election to the State Convention than authorized.

Eliminate the necessity of the secret ballot election and the requirement of storing the ballots for one year.

PROPOSED LANGUAGE: Article V Section 4.A. c and d (re-letter e as d)

A. Allowances

 - a. The 2024 allowance of the State President shall be \$330.00 per month.
 - b. The 2024 allowance of the State Vice-President shall be \$193.00 per month.
 - c. The 2024 allowance of the State Secretary/Treasurer shall be 40K step 12 Full time with benefits equal to benefits provided by USPS. (*The Assistant position is deleted*)
 - d. The 2024 allowance of the State Committeeperson shall be \$148.00 per month.

INTENT OF / REASON FOR CHANGE:

To make the state secretary position full time and discontinue the assistant position.

Due to the lack of leave replacements, it is becoming harder and harder for anyone holding these positions to get adequate time to do their job. Sometimes their route does not get delivered at all making the secretary file a grievance for a full-days relief and or just denied leave over all making a very complicated and difficult job even more so.

PROPOSED LANGUAGE:

D. Each County Secretary shall notify all members in writing at least 15 days prior to the county meeting, stating the time and place of such meeting and business to come before the meeting, e.g., election of county officers and election of delegates to the State Convention. However, the election of the delegates to the State convention must be by secret ballot. All Counties shall hold their spring meeting at least **50** days before the opening of the State Convention.

INTENT OF / REASON FOR CHANGE:

Department of Labor requires 50 days before instead of 40 days.

Members electing to be a member outside of their initial hiring subordinate unit, must notify the State Secretary Treasurer in writing. The State Board shall combine any inactive unit with an adjoining active county.

INTENT OF / REASON FOR CHANGE:

To give members options.

With the consolidation of offices being moved to S&DCs in some cases it will change the county in which a member is assigned to making it harder or farther away for the member to be an active union member. To have the county unit assignments applied to all members equally.
