### A Message from Your WIRLCA Board

As I sit here typing this message to you, our membership, a lot has changed since our last newsletter.

Some of you may have noticed that there wasn't a Nov/Dec state newsletter. As a board, we sat down at our July board meeting and decided that being extremely responsible with the membership's money was one of our top priorities. We are required to publish at least four newsletters yearly, and we were doing six.

With increased postage, paper and printing fees having a large impact on our budget, we decided that eliminating one issue was a fiscally responsible thing to do. Our state editor recommended that eliminating the Nov/Dec issue, would have the least amount of negative impact to the membership. That issue is usually at the quietest time of the year as far as events going on within the state and the NRLCA.

The other noticeably large change since the last newsletter, has been the makeup of your state board. Many of you may or may not have heard that WIRLCA President Kim Mac Donald was offered the opportunity to work full time for our National Steward System (NSS). Kim accepted the position which provided her a great opportunity to help members win grievances and be heard! While working for the national steward system, she is unable to hold a position on the state board, so she officially resigned the position of president on September 30th.

With Kim's resignation, I officially became your President on October 1st, pursuant to Art. V, Sec. 2. B. 1 of the WIRLCA Constitution. I was a little nervous at first, after serving several years as a committeeperson and a couple of years as your vice-president, but I am excited for the challenge before me and this board. I believe everyone on the current board has stepped up to these challenges before us.

I, as well as your WIRLCA Board, would like to thank all those that helped us through this transition. It is not something that occurs often, and we had many questions and challenges.

### **Spring Conference 2025**

The 2025 WIRLCA Spring Conference will be held at the Holiday Inn & Suites, 1000 Imperial Dr, Rothschild WI on March 9, 2025. This year we decided to combine local officers training with the spring conference, moving it to a oneday event.

The morning will consist of local officer training and to be followed by two guest speakers, to be announced later. We're working on scheduling a local plant manager along with a national congressperson. With several offices reporting delays in receiving their mail on time or not at all, it's been expressed they would like answers to why this is happening and what's being done to correct the situation. In the afternoon session, we will cover the two most important areas which determine your route's evaluation.

- Address Management System (AMS) Edit • Book Monthly Process: Edit books must be updated by the assigned rural carrier monthly. Failure to do this could greatly impact the outcome of your route evaluation. Lisa Wojnarowski, Manager of the Address Management Systems for the Wisconsin District, will be doing a presentation on what your responsibilities are each month to ensure your route is properly credited. Your edit book responsibilities don't stop there, once your edit book is returned/updated, it must be downloaded by the Supervisor/ Designee in the presence of the assigned rural carrier and all missing information must be updated. This process will be explained in detail.
- RRECS MAPPING MAINTENANCE: Mapping is one of the most critical pieces of the RRECS system. Updating your edit book starts the

process of changing your route, mapping finishes the process so this information is credited properly to your route. Melissa Tarlton, a USPS RRECS facilitator, will be doing a presentation on mapping. The presentation Melissa gives is worth its weight in gold, you will learn what reports need to be done, who should be doing these updates, and when/what reports you can print after the updates for your records to verify monthly.

Questions & Answers: WI District Representative Greg Dietzler will be taking and answering questions following/during the presentations.

We will be providing a light lunch during a short break between the morning and afternoon sessions. The registration form is included in this issue of the magazine. There is a requirement to register for lunch, which includes a \$5.00 refundable fee if you attend. The fee is included so we can get a head count on attendees without over-purchasing meals. If you decide not to do the lunch, please still register so we can ensure we have enough handouts printed for all attendees.

You do not have to attend the whole day; you can travel in for the afternoon session only. The conference was planned to give carriers a chance to travel on the day of or carpool with their co-workers focusing mostly on the RRECS training.

If you have been denied doing your monthly mapping or your management has taken it over for you, you have put your paycheck in someone else's hands.

Hotel reservations can be made by calling (715) 355-1111. For those booking a hotel room for Saturday night please join us for a PAC fund-raiser at 6 pm.

### Time to get ready!

As this year comes to an end there are a lot of things to get ready for that are coming up sooner than we think. Some of the events are the WIRLCA Spring Conference, the 30th Mid-States Conference, your local county meeting, and the 120th WIRLCA State Convention. The ones I will be touching on in this article are Mid-States, local union meetings, and your State Convention.

The 30th Mid-States Conference is in Springfield IL. The date for Mid-States is May 2nd through the 4th, 2025. This is where the first Mid-States Conference was held. A Mid-States Conference Registration form can be found on the NRLCA website, under the tab "Area Conference", or on pages 28 in this magazine. The "Mid-States" is a great way to get one-on-one time with our national board. Friday night is a fun time at the meet and greet. Then on Saturday night is the banquet. The theme of the banquet is "Kentucky Derby." The entertainment for Saturday Night will be Hypnotist: Michael C. Anthony. Registration for Mid-States is due by April 1st, 2025. If vou plan on attending the meet and greet, banquet, or partaking of any of the provided meals they will not accept late registration. Rooms are available at the President Abraham Lincoln Double Tree by Hilton Hotel. The rates are \$125 for single or double occupancy, \$135/triple and \$145 quad.

Local county meetings will be here before we know it. Your local unit will be sending out the date, time, location, and agenda for the meeting. Watch your mailboxes for meeting reminders. Make sure your local secretary has your current address. One of the things that can be discussed at your local meetings is how to spend your local county unit funds. An example of this would be; having your local county meeting meal paid. Another example would be; making a motion to

county delegates, those that will be attending the state convention, paid an amount for going.

How to become a delegate for the WIRLCA State Convention? Every local unit has a certain number of delegates allowed to vote on the items that come up at our state convention. The local units get one delegate for every five members in your local unit. If you want to become a delegate for your local unit at the state convention, you will need to be voted for and have your name put on the delegate list at your local spring meeting.

The 120th WIRLCA State Convention is approaching fast. The date for the convention is June 20th -22nd. It will be held at the Sheraton Milwaukee Brookfield Hotel in Brookfield, WI. Check the official WIRLCA website, www.wirlca.org, for more information. There will be more information on your state convention coming out soon. Hope to see you all there.

The vacancy was created due to the move of 2023-24, 25 president, Kim MacDonald to the position of full-time ADR in the Wisconsin District, National Steward System (NSS).

### **Starting Anew**

As my title indicates we are going to be starting not only a new year but also a new session of Congress. Normally I would list all the titles and numbers of pending legislation but as it is, all those pieces of legislation, except for one, are now history. That's right, as we move into the 119th Congress all the bills that were introduced in the 118th session of Congress will get new numbers if they are reintroduced.

So, as I am writing, the Senate is voting on the one bill that has been passed by the House. It is expected to pass the Senate and then be sent on to the President for his signature. That bill is H.R. 82 – the *Social Security Fairness Act*. When this is done, then the question is how long it will take to recalculate the benefits for those affected by the repeal of the law. At this time, I have not found any estimates on how long this will take.

As the new congress and administration get organized, what legislation will be reintroduced is impossible to predict. So once again, we will have to wait and see. As with any new session of Congress, there is a lot of organizing to be done so I don't expect a lot to happen in the first several months of 2025.

With all this reorganization and many new members of Congress, the need to introduce the NRLCA to these individuals is never more important than now. So, the need to continue to support the NRLCA PAC continues— because the fight to keep our hard-won benefits never ends. I believe the passage of the *Social Security Fairness Act* – H.R.82 is a great example of the need to continue educating the members of Congress that some legislation is just plain unfair. Yes, it took some 30 years for this to happen, but the fact that it wasn't allowed to die, should tell us that some things are worth fighting for. With that being said I am going to use "The Buy Back Bill" as another example of legislation we can't let die.

I for one will be contacting my representative and encouraging him to reintroduce this issue. I suggest we all do the same because this issue

had gained momentum in the last congress and I believe the grassroots approach is the

best way forward. As soon as the new congressional contacts list is released, I will have the Wisconsin representatives' contact information on our state websitewww.wirlca.org. If you know who your representative is, do not hesitate to contact them and tell them why this legislation is so important to you personally. Along with this effort, our Legislative Department at the NRLCA is working continuously to ensure our voices are heard on Capitol Hill. The only funding they have to use (for supporting those individuals who are supporting our interests) is direct contributions from the membership. I always believe it's important to remind everyone that none of our dues are going into the PAC fund.

As always, the forms for either payroll deduction or an EFT contribution to the NRLCA PAC are available by scanning the handy QR code located on the back cover. If you prefer, you can send a check made out to NRLCA – PAC to me at the address listed on the inside cover of this newsletter. Do not forget that it only takes a \$5.00 contribution, along with filling out the contribution receipt, to get your name into the drawing at the state convention for a prize worth \$250.00.

Don't hesitate to participate in any games of chance or other activities coming your way at this year's WIRLCA Spring Conference, your local spring meetings, and of course the PAC auction at the upcoming 120th WIRLCA State Convention.

### Thank You!

Another Holiday season has been completed and another recorded number of packages have been delivered. You all don't hear it enough, so please accept my heartfelt, "Thank You" for all your hard work. I hear too often that there is little positive reinforcement, or thanks given to rural carriers. This is upsetting to hear.

Our job over the holidays is exponentially demanding, onerous, and with little appreciation because the extra work has somehow become an expectation. It is hard for the public to comprehend the number of hours we work or what rural carriers go through so that they can enjoy their respective holidays and families. The work we do is dangerous. Working out in the dark, in the middle of nowhere, through winter storms and icy roads, and with no cell phone reception, is scary. Add to this our exhaustion, lack of sleep, and the stress that comes with the job, it's easy to see why our subs don't stick around. Fatalities and motor vehicle accidents have risen 15.64 % since FY22.

Due to this increase, the USPS felt the need to take additional action in creating a Headquarters Safety Engagement Observation Team to assist district field offices in conducting safety observations. This safety team will start conducting safety observations during the month of December and will be ongoing throughout FY-2025. Members of this safety team will be monitoring, observing, and conducting safety observations during the performance of carrier street delivery duties. This team will be driving official postal vehicles and will provide a proper postal ID if there is a need to interact with employees. With this knowledge, I wanted to share three of the many safety issues that I believe this team is looking for:

- If you leave the seat of your vehicle, your keys need to come out of the ignition. I have seen carriers placed on EP (Emergency Placement) and disciplined for leaving their vehicle running while delivering a CBU or package. Please don't take that chance and forget to take the keys out.
- Avoid backing whenever possible. It's impossible to never back up, but this tends to be the cause of most preventable accidents.
- Do not engage in eating, drinking, or talking on the phone while your vehicle is in motion.

If you want to read and become more knowledgeable about driving safety, ask your manager for a PS form 4584 to see what types of observations will be made. If you do happen to have an accident, regardless of a vehicle or non-vehicle, the contract is very precise on what you should do. Vehicle accident reporting is found in your <u>Rural Delivery Carrier Duties and Responsibilities Handbook: PO-603, Chapter 1, Section 173</u>.

"Report all accidents. Having your own automobile insurance does not relieve you of the responsibility to submit a report on Standard Form (SF) 91, Operator's Report of Motor Vehicle Accident, to your postmaster or supervisor. A Vehicle Accident report kit, Item 087-H, must be carried in the vehicle when it is used for official business. Request this kit from the postmaster or supervisor and be sure the envelope is sealed. If it is not, obtain a sealed (Continued from page 14)

replacement."

If involved in an accident, regardless of the cause or the amount of damage, injury, or death, remain at the scene until you have:

- a.Obtained aid and assistance for any injured person
- b.Safeguarded the scene against further accident.
- c. Secured and protected the mail.
- d.Notified the postmaster or supervisor, or designee
- e. Notified local or state police as required.
- f. Provided other drivers or principal parties to the accident the information required by law using PS form 4585, Postal Driver Accident Info.
- g.Obtained, as far as practicable, the names and addresses of all principals and witnesses using PS Form 4586, accident information. Do not make any statements admitting personal or postal liability, or criminal negligence, or attempt to negotiate an agreement or settlement with anyone.
- h.Completed SF 91. This report may be prepared at the scene of the accident or immediately after. You must submit it to your postmaster or supervisory before going off duty on the day of the accident. Regardless of the amount of damage, injury, or deaths, accidents must be reported on SF 91 even though the other principles involved state that no claim will be filed for or against the Postal Service or its employees. SF 91 is also required for accidents involving other postal personnel, equipment, vehicles, or property. NOTE: If you are physically unable to comply with the preceding instruction, the postal official in charge ensures that the required investigations and reports are made."

For accidents other than vehicle, if you are injured on the job:

- Notify your postmaster or supervisor so PS Form 1769, Accident Report, can be completed.
- Obtain a Form CA-1 Federal Employee's Notice of Traumatic Injury and Claim for Continuation of Pay/Compensation, from your postmaster or supervisor any time you are injured on the job. Complete and return it to your postmaster or supervisor within 48 hours of the time of injury.

The most important advice to heed regarding accidents is to report it right away. DO NOT wait until you finish your route or wait until the next day. In fact, if you are aware of a safety hazard, this needs to be addressed immediately. Ask management for a PS form 1767 (Report of Hazard, Unsafe Condition or Practice), fill it out, and return to management. Make sure to keep a copy for yourself and notify your district level steward immediately. These forms will help us hold management in compliance with Article 14. Do not work unsafely just to make the numbers. Your return time on your PS form 4240 is a goal. There is no requirement on the rural side to be back before your return time and this is addressed in Article 8.2.

"The carrier's work day may vary above or below the daily evaluation of the route as mail volume fluctuates and road and weather conditions change."

There will be days when we expect a few inches of snow and it turns into a snow storm that is so severe they suspend schools, sporting events, close restaurants, and shut down entire roads.

You may see on the news that mail delivery is suspended and wonder if you must go to work. I get many calls when snowstorms hit and my advice is the same based on the contact. Regardless of what you see on the news, or how bad the roads are, carriers must still report to work unless USPS specifically contacts you and tells you not to report.

Use the emergency hotline or contact your manager as resources on instructions. If you are told not to report by management, please document who you talked to, along with the date and time, and hang on to those documents in case issues come about.

It is entirely possible you will make it to work but the truck didn't and you won't have much to do. Management has a few things they can require you to do if this occurs like: Case your mail that is there, work on your Edit Book, update your LTM, DPM, work on case labels, watch a safety or service video, and etc. Basically, any rural work that pertains to your route is acceptable. You cannot be required to do other crafts' work or be forced to stay and do nothing. If that occurs, keep track of your time and contact your steward. A grievance may need to be filed based on the factual circumstances of each induvial case.

We work a dangerous job, but with the information above, you are better equipped to prevent some accidents, but also know how to report any accidents that do occur.

### The Matrix or "Order of Consideration"

Article 30.2.D.1 of our contract requires the establishment of a leave replacement assignment list in each office. This list has commonly been referred to as the "Matrix." Or "The Order of Consideration". The list was introduced in an effort to clarify the proper scheduling of leave replacement assignments beyond the primary assignment. It also allows for utilization of leave replacements assigned to a specific delivery unit, once the office matrix is exhausted.

When your District Stewards visit each of your offices, one of the first things we are looking for is this document. It should be in clear view of every employee, making it available to cross reference whether or not management is scheduling correctly. There are some key points that each leave replacement needs to be aware of —

- The Matrix lists all leave replacements in the delivery unit and includes all routes.
   "Delivery unit", for this purpose, is defined as a physical location containing one or more five-digit zip codes under the control of one postmaster or station/ branch manager or one RMPO under the control of one postmaster in the APO. In no case will a separate Matrix be created between these locations. The Leave Replacement Matrix is utilized when scheduling for all routes.
- Leave replacements, apart from PTFs (des 76)and assigned Auxiliary route carriers (des 74, 79), may be assigned to a maximum of three positions. PTF and Auxiliary carriers (Continued on page 17)

may only be shown on their primary assignment. In non-formula offices, Auxiliary carriers may opt for an assignment to the assigned auxiliary route 5 days per week and one full route 1 day a week.

- All RCAs are to be shown on their primary route assignment first and foremost. Once qualified on additional routes RCAs may be placed in secondary or tertiary positions. It is possible for RCA's to be assigned to a secondary and tertiary, two secondaries or two tertiary positions. An additional list shall include all leave replacements, by seniority, to those routes they are qualified and then unqualified to serve.
- Once a Matrix is created, there is no provision • that allows for "re-doing" assignments. It is a living document that is updated, at management's discretion. as leave replacements are hired, converted, or have left the Post Office. Management may allow for a change in assignments for all leave replacements or may choose to offer a select few. Unlike primary assignments, there is no "round-robin" that is required once a position is filled. Management has the right to cross-train and place those carriers on the Matrix prior to offering movement to other qualified RCAs. It is important to note that management MUST offer the secondary position, if not already filled, to RCAs that currently show in the tertiary spot.
- Once the Matrix is established, management is required to schedule accordingly. When the need to cover a route happens, management must utilize the RCA assigned to the primary position first. RCAs assigned to

work on their primary position are entitled to work the full evaluation of the route when the regular carrier is absent. There is no entitlement to overtime when serving an entire work week, with the exception of scheduling on a day-to-day basis.

- Whenever the primary leave replacement assigned to serve a route is temporarily unavailable or there is no assigned leave replacement, management may assign the work to an available PTF rural carrier in the office. If there is no PTF available, management must refer to the matrix and offer the assignment to the leave replacement designated as second replacement for the route. If this employee is unavailable or there is no second replacement, then the employee designated as the third replacement will be offered the assignment.
- Upon exhaustion of the primary, secondary, and tertiary leave replacements, management selects qualified, then unqualified leave replacements, in order of seniority to serve the route. Leave replacements assigned to routes, other than their primary route, are not entitled to overtime. However, leave replacements are entitled to overtime prior to management utilizing regulars per Article 8.5 of the National Agreement.

For a more comprehensive guide to the Matrix, please download the NRLCA App. Located under the steward tab is a reference guide available for your use. As always, your local and district stewards are always here to assist you with questions.

### **ORDER OF CONSIDERATION**

Covering a route when the regular rural carrier is absent

This document represents the position of the NRLCA as supported by the contractual and other language cited.

#### 1. Primary Assigned Leave Replacement

- A. Entitled to weekly Evaluated Hours when covering route for full week. May only then be replaced to avoid overtime or additional overtime. (Article 30.2.0.)
- B. When covering route for entire week, they may be required and/or request to take a relief day on J or K routes. The relief day is not necessarily the same as the regular carrier. (Article 30.2.H)

C. When a leave replacement is being scheduled on a day-by-day basis, the primary substitute, RCA or RCR must be scheduled for work on their primary assignment if available, even if this results in compensation at the overtime rate. (Pre-Arbitration Settlement GOOR-4Q-C 02139495, March 14, 2005 (M-84)

2. If the primary assigned leave replacement is not available, management may assign an available part-time flexible rural carrier (PTF) before assigning the second or third leave replacement on the matrix.(Article 30.2.D.2. and Pre-Arbitration Settlement GOOR-4Q-C 02139495, March 14, 2005 (M-84)

3. Assign the leave replacement in the secondary spot on the matrix. No entitlement to overtime. (Pre-Arbitration Settlement G00R-4Q-C 02139495, March 14, 2005 (M-84)

4. Assign the leave replacement in the tertiary (third) spot on the matrix. No entitlement to overtime. (Pre-Arbitration Settlement GOOR-4Q-C 02139495, March 14, 2005 (M-84)

5. Assign, by seniority, another qualified substitute, RCA, or RCR in that delivery unit. Qualified means having received training or been utilized on the route. No entitlement to overtime. (Article 30.2.D.3 and (Pre-Arbitration Settlement G00R-4Q-C 02139495, March 14, 2005 (M-84)

6. If no qualified substitutes, rural carrier associates, or rural carrier relief employees within the delivery unit are available, the Employer may designate any other leave replacement in the office prior to selecting a regular rural carrier to work in accordance with Article 8.5.

7. If no other leave replacements in the office are available, the Employer may schedule a leave replacement from another office before selecting a regular rural carrier to work in accordance with Article 8.5. If a leave replacement is scheduled to case and carry a regular rural route in his or her assigned office, the leave replacement is considered unavailable to work in another office. Article 30.2.D.5

8. Management may, on some occasions, split a route or schedule an RCA to serve a regular route and an auxiliary route. (NOTE: The NRLCA position is that the term "on some occasions" does NOT include scheduling multiple assignments or splitting routes on a repeated or on-going basis.) Except in emergency situations, management must not schedule a leave replacement to serve on two full assignments or one full assignment and one or more partial assignments in a single day if the evaluations of these assignments total twelve hours or more. (Step 4 Settlement G95R-4G-C00170298 (R-96), April 24, 2002, and Wilson Letter September 1, 2000 (P-115)

9. Select a regular carrier to work in accordance with Article 8.5

A. Select carriers on the Relief Day Work List (RDWL) in order of seniority on a rotating basis, to work on their relief day.

Carriers on RDWL are paid one of three ways, **at their option**: (Article 9.2.C.5.f.)

- DACA Code R- Carrier and manager mutually agree on X day within next 12 weeks. No additional compensation. Form 3971 completed. Same consideration as approved annual leave.
- DACA Code 3- 50% additional compensation and X day scheduled by management within next 12 weeks. Management must give 3-days' notice when scheduling X day. (Wilson Letter September 1, 2000 (P-115)
- 3. DACA Code 5- Carrier receives 150% of daily evaluated pay. No X day.

B. If the need exists, the Employer will accept volunteers from regular carriers not on the list before requiring regular carriers not on the list to work their relief day. Such requirement will be by juniority. (Article 8.5.A.2)

C. Require a regular carrier not on the RDWL to work. This is done by juniority and does not rotate. DACA Code 3 is the only compensation choice. (Article 9.2.C.5.g.)

**Notes:** Any regular carrier may be bypassed from working a relief day if the hours worked would cause them to exceed 2080 hours for the guarantee year or 56 hours for the week. (Article 8.5.C.)

Regular carriers with annual leave, sick leave, or an X day scheduled adjacent to their relief day, will not be required to work the relief day. (Article 8.5.A.3)

10. In emergencies, any other qualified employee may be assigned. (Article 30.2.D.6)

### WISCONSIN ARMED FORCES VETERANS' CLUB

The article this month will be a report on the Wreaths Across America event held on December 14th, 2024.

Back story: It started with a 12-year-old boy who won a trip to our nation's capital selling newspaper subscriptions as a paperboy for the Bangor (Maine) Daily News. As part of the trip to Washington, D.C., they toured the district and went to Arlington National Cemetery.

The cemetery left an imprint that he carried throughout his life. Morrill Worcester was that 12-year-old boy.

In 1992, Morrill Worcester was producing wreaths in a warehouse in Columbia Falls, Maine. He'd graduated from the University of Maine, married his wife Karen, and started Worcester Wreath Company, founded in 1971. His biggest customer canceled its contract during the holiday season; a loss that could have cost the Worcester's the company.

The surplus of 5,000 balsam wreaths needed to be used and Morrill remembered the day, at the age of 12, he visited the graves of those who gave their all for our country. That is when the makings of Wreaths Across America was created.

With the help of VFW and American Legion Posts the excess wreaths were placed of the graves of interned soldiers in an older almost forgotten part of the cemetery. Morrill Worchester was so moved by the placing of wreathes on the veterans graves that he told his wife Karen, "Next year it isn't going to be a mistake which causes us to bring 5000 wreaths here, I'm going to do it every year."

That is what led to the Wreaths Across America annual event. In 2024 over 3.5 million wreaths were place on veteran's graves in over 4600 locations across America. This event continues to grow every year. Wreaths Across America is celebrated in all locations on the same day, always a Saturday.

On December 14th, 2024, in New Hope, WI, 28 wreaths were placed on the graves plus the ones on the archway and fence with flags representing all branches of service as well as a POW/MIA and US Flag. The cemetery is a regular church cemetery with 28 veterans graves.

The weather was cool but not exceptionally cold so the program was held in the church basement. It probably was almost a half hour long. It included the National Anthem presented by students from Amherst High School, a history of WAA, instructions for proper laying of the wreaths, and a roll call of the names of all veterans buried in the cemetery. The church bell tolled once after each name was read. We then placed the wreaths on the graves followed by the playing of Taps by an Amherst High School student. Attendees were invited back into the basement for refreshments. About 25 were in attendance which probably had doubled our previous high.

I have invited other postal employees thru the newsletter but have not had any takers. Several rural carriers/retirees have attended the program at the Spooner Veterans Cemetery for a number of years.


